BAC-A RESOLUTION NO. 097-B SERIES OF 2022

A RESOLUTION RECOMMENDING NEGOTIATED PROCUREMENT UNDER EMERGENCY CASES FOR THE SUPPLY AND DELIVERY OF LABORATORY REAGENTS FOR USE OF THE GENERAL EMILIO AGUINALDO MEMORIAL HOSPITAL

WHEREAS, the Provincial Government of Cavite intends to procure for the **Supply and Delivery of Laboratory Reagents for Use of the General Emilio Aguinaldo Memorial Hospital** with Approved Budget for the Contract (ABC) amounting to **Seventy Thousand Nine Hundred Thirty-Three Pesos and Thirty-Four Centavos (Php70,933.34)** as indicated in Purchase Request (PR) No. 2022-8-H-675 dated August 17, 2022;

WHEREAS, Sec. 48.1 of Rule XVI (Alternative Methods of Procurement) of the Implementing Rules and Regulations (IRR) of the Government Procurement Reform Act (R.A. 9184 or the GPRA), states that *"Subject to prior approval of the Head of Procuring Entity, and whenever justified by the conditions provided in this Act, the procuring entity may, in order to promote economy and efficiency, resort to any of the alternative methods of procurement provided in the Rule. In all instances, the procuring entity shall ensure that the most advantageous price for the Government is obtained"*;

WHEREAS, considering the time for action on procurement activities, alternative mode of procurement is necessary since the General Emilio Aguinaldo Memorial Hospital (GEAMH) is in urgent need of laboratory reagents for its diagnostic services;

WHEREAS, Section 53.2 of the GPRA IRR states that:

"Emergency Cases. In case of x x x x, or when time is of the essence x x x x or other causes where immediate action is necessary x x x x to prevent damage to or loss of life or property, or to restore vital public services"

WHEREAS, **PRIME MEDIX ENTERPRISES**, a legally, technically, and financially capable supplier as evaluated, checked and verified by the Bids and Awards Committee Technical Working Group, with business address at **Ortigas Avenue Ext., Sta. Lucia, Pasig City**, represented by **Mr. Edgardo B. Liu**, submitted quotation for the laboratory reagents amounting to **Seventy Thousand Nine Hundred Thirty Pesos (Php70,930.00)**;

NOW THEREFORE, the Bids and Awards Committee for Goods, Services, and Consultancy (BAC-A) **RESOLVES** as it is hereby **RESOLVED** to **RECOMMEND** Negotiated Procurement for Emergency Cases for the **SUPPLY AND DELIVERY OF LABORATORY REAGENTS FOR USE OF THE GENERAL EMILIO AGUINALDO MEMORIAL HOSPITAL**.


