1. The **Provincial Government of Cavite**, through its GENERAL FUND for CY 2023 approved by Sangguniang Panlalawigan, intends to apply the sum of **ONE MILLION FIVE HUNDRED THOUSAND PESOS (P1,500,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract **FOR PROVISION OF MEALS FOR REGULAR SESSIONS, SPECIAL SESSIONS AND MEETINGS TO BE HELD IN THE OFFICE OF SANGGUNIANG PANLALAWIGAN**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Provincial Government of Cavite now invites bids for the above Procurement Project. Delivery of the goods is required as scheduled upon receipt of Notice To Proceed. Bidders should have completed, within 2 relevant years from the date of submission and receipt of bids at least one (1) contract similar to the Project the value of which, adjusted to current prices using the PSA's CPI, must be equivalent to at least 50% of the ABC for Expendable and Non-Expendable supplies with proof thereof. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
4. Prospective Bidders may obtain further information from Provincial Government of Cavite and inspect the Bidding Documents at the address given below during Monday to Friday from 8:00A.M. to 5:00 P.M.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **February 13, 2023**, from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Thousand Pesos Only (Php5,000.00)**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person.
6. The Provincial Government of Cavite will hold a **Pre-Bid Conference on February 20, 2023 at 2:00 P.M.** at **2nd Floor Provincial Capitol Building, Trece Martires City**, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission at the 2nd Floor Provincial Capitol Building, Trece Martires City, on or before **March 06, 2023 at 1:30 P.M.** Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
9. Bid opening shall be on **March 06, 2023 at 2:00 P.M.** at **2nd Floor Provincial Capitol Building, Trece Martires City**. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The Pre-Bid Conference will be held via Zoom. Details on the said Zoom Conference are indicated in the Additional Information of the Philgeps posting for the above project.
11. In any case of the above dates is declared a special non-working holiday, it will be automatically reset on the next working day at the same time and venue for the submission and opening of bids.

12. In case of tie or in the event two or more of the bidders have been post qualified as LCRB of HRRB, the measure determined by the procuring entity shall be non-discretionary and non-discriminatory such that the same is based on sheer luck or chance. The winning bidder should be determined by "Toss Coin" in the presence of supplier concerned during BAC meeting pursuant to GPPB Circular No. 06-2005 dated August 05, 2005.
13. The Provincial Government of Cavite reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidder
