**Invitation to Bid for the Installation of 44 Units 60 Watts LED Solar Powered Streetlights (Spacing = 25m, Height = 6m) at 29M Lao-Lao, Cavite City, Cavite**

1. The **Provincial Government of Cavite**, through the CY 2025 20% Development Fund intends to apply the sum of **Three Million One Hundred Twenty Five Thousand Five Hundred Pesos (3,125,500.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Installation of 44 Units 60 Watts LED Solar Powered Streetlights (Spacing = 25m, Height = 6m) at 29M Lao-Lao, Cavite City, Cavite**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The Provincial Government of Cavite now invites bids for the **Installation of 44 Units 60 Watts LED Solar Powered Streetlights (Spacing = 25m, Height = 6m) at 29M Lao-Lao, Cavite City, Cavite**. Completion of the Works is required as indicated in the Bid Documents specified in SCC1.16. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act". Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from BAC Secretariat of the Procuring Entity and inspect the Bidding Documents at the BAC Office, Upper Ground Floor, Cavite Government Center (New Provincial Capitol Building) San Agustin, Trece Martires City during Monday to Friday from 8:00 a.m. to 5:00 p.m.

5. A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **Five Thousand Pesos (P5,000.00)**.

6. The Provincial Government will hold the Pre-Bid Conference on January 23, 2025 at 9:30 a.m., at BAC Office, 2<sup>nd</sup> Floor Old Capitol Building, Trece Martires City, which shall be open to all interested Bidders.

7. Bids must be delivered to the address below on or before February 06, 2025 at 9:30 a.m. at BAC Office, 2<sup>nd</sup> Floor Old Capitol Building, Trece Martires City. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18;

8. Bids will be opened on **February 06, 2025, at 10:00 a.m.**, in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

9. The Provincial Government of Cavite reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
